VEHICLE PERMIT PROGRAM**

Your application for a Recycle Center entrance permit has been approved. Two permits are issued, which are to be used for entrance to the Recycle Center. The second permit is provided for your convenience or use in your second vehicle. If you should find the need for a replacement permit, please contact the Public Works Department at 837-3050.

*The permit should be affixed to the inside lower left hand corner of your vehicle windshield, by its own adhesive, where it is visible to the Recycle Center attendant.*

Please remember that inappropriate use of the Recycle Center by users who did not pay the use fee on their property taxes increases operational costs and could contribute to higher special fee charges. Therefore, it is imperative that the permits be used for your purposes only.

The Recycle Center is located at 1798 South Bird Street and is open to accept yard waste, brush materials, used appliances, motor oil, used motor vehicle oil filters and oil absorbent materials, scrap metal, flattened cardboard, antifreeze and some electronics.
