New events and committees have been created due to increased participation of BID businesses. Three new committees within Recruitment & Retention were created, with the goal creating more activity amongst the business.

Six bike racks were installed throughout the BID area in coordination with Public Works.

First year of a 70% staffed position through the City of Sun Prairie.



2018 BUDGET HIGHLIGHTS

Directional (wayfinding) signage and a portion of Façade improvement grants will carryover as a 2018 expense.

The BID Board is committed to supporting the Dream Park which will come out of fund balance for the 2018 budget.

DESCRIPTION

Pursuant to Section 66.1335 Wisconsin Statutes (i.e. the Community Development Authority Law), the City of Sun Prairie City Council passed a resolution in May of 2000 creating a Community Development Authority (CDA). The CDA was created as a "corporate body politic" authorized to transact business and exercise any and all powers, duties, and functions defined for housing and redevelopment authorities by this statute and related sections of Chapter 66 as amended from time to time.

The CDA's primary role has been to facilitate borrowing for infrastructure and acquisition costs related to redevelopment projects in the downtown area (TID 8), as well as the 151-Reiner Road Interchange area (TID 9), reviewing and providing direction on specific redevelopment proposals in these Districts, and facilitating the sale of City or CDA owned parcels in these Districts.

The Community Development Department serves as the staff liaison to the CDA. The CDA consists of seven appointed members, two of whom are members of the Common Council, and the Mayor who serves as chairperson.

2017 BUDGET HIGHLIGHTS

The CDA facilitated and approved the sale of a City-owned parcel in TIF 9 for a medical clinic.

The CDA acted as the primary working group for the Central Main Street Redevelopment Plan. It provided recommendations to the City Council regarding the redevelopment of the City-owned lot located at 132 Market Street.

The CDA initiated the review and update of the CDA's organizational resolution to an ordinance and initiated the review of a proposed application for TIF assistance.

2018 BUDGET HIGHLIGHTS

The CDA will continue to meet as necessary to consider requests for TIF assistance, offers to purchase City or CDA owned parcels. A likely focus for 2018 will be the implementation of the pending Central Main Street Corridor Redevelopment Plan currently being worked on by the CDA.
