RESOLUTION TO EXCEED REVENUE CAP COMMENCING WITH THE 2019-20 SCHOOL YEAR BY AN AMOUNT OF \$5,000,000

BE IT RESOLVED by the School Board of the Sun Prairie Area School District, Dane and Columbia Counties, Wisconsin, that the final school district budget shall include an amount not to exceed \$5,000,000 in excess of the revenue limits imposed by Section 121.91 of the Wisconsin Statutes each year beginning with the 2019-20 school year on a recurring basis for the purpose of paying staffing, operation and maintenance costs of the new high school; reducing capital project borrowing costs of the new high school; and improving teacher compensation.

Shall the School Board of the Sun Prairie Area School District be authorized to exceed the revenue limit under Section 121.91 of the Wisconsin Statutes by an amount of \$5,000,000 each year beginning with the 2019-20 school year on a recurring basis for the purpose of paying staffing, operation and maintenance costs of the new high school; reducing capital project borrowing costs of the new high school; and improving teacher compensation as provided in the foregoing resolution?
