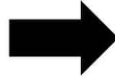

- Payment stub from the tax bill
- Endorsement on back of escrow checks only:
 - If there are multiple names on the "Payable To:" line - all parties must sign the back of the check before submitting to City of Sun Prairie.
- For a receipt:
 - Include a self-addressed, stamped envelope. Finance Department will mail a copy of your receipt after payment is made.

FIS charges a fee equal to 2.35% of the amount of the payment.

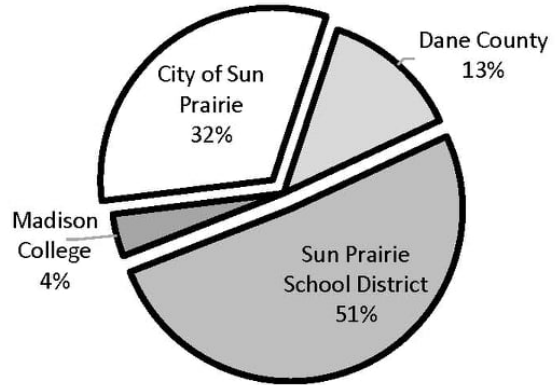

Refunds

If your escrow check exceeds the amount due for your taxes, a refund will be issued to the name and address of the homeowner on the tax bill. The refund will be issued within 30 days.

DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible! **To Qualify:** Your home must have been the **PRIMARY** residence for you or the previous owner on January 1, 2020. If you feel you qualify for the Lottery Credit: You may obtain the Lottery Credit Claim Form on our website, www.cityofsunprairie.com (Finance Department: Property Taxes Section), contact the Treasurer's Office at 300 East Main Street, or call 608-825-1192, prior to **January 31, 2021**.

AM I ELIGIBLE FOR THE FIRST DOLLAR CREDIT?

If your real estate bill has an **"assessed value improvement"** amount, the credit should automatically show on your bill. Anyone entitled to the credit that did not receive it must appeal directly to the Wisconsin Department of Revenue at 608-266-2486.

Dog Licenses

Dog licenses are to be obtained every year, effective January 1st. Due to the increase in COVID-19 cases, City Facilities are closed to the public. Dog licenses can be obtained online by visiting <https://sunprairiewi.viewpointcloud.com/> or by downloading the form on our website and submitting it via mail, along with your dog's 'Certificate of Rabies' to 300 E Main Street.
