- If there are multiple names on the "Payable To:" line - all parties must sign the back of the check before submitting to City of Sun Prairie.
- If paying by mail or dropbox and you would like a receipt, please include a self-addressed, stamped envelope.

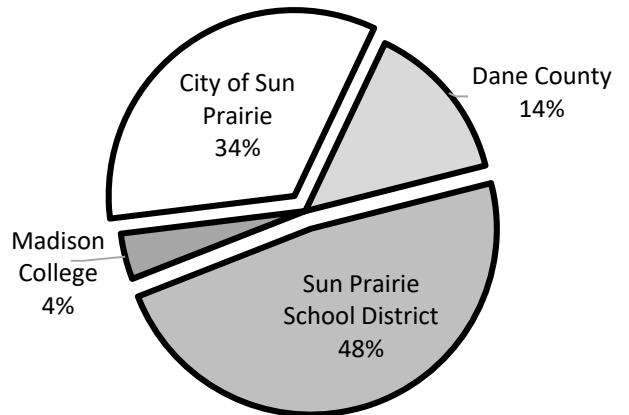

## Refunds

If your escrow check exceeds the amount due for your taxes, a refund will be issued to the name and address of the homeowner on the tax bill. The refund will be issued within 30 days.

### DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible! **To Qualify:** Your home must have been the **PRIMARY** residence for you or the previous owner on January 1, 2021. If you feel you qualify for the Lottery Credit: You may obtain the Lottery Credit Claim Form on our website, [www.cityofsunprairie.com](http://www.cityofsunprairie.com) (Finance Department: Property Taxes Section), contact the Treasurer's Office at 300 East Main Street, or call 608-825-1192, prior to **January 31, 2022**.

### AM I ELIGIBLE FOR THE FIRST DOLLAR CREDIT?

If your real estate bill has an "assessed value improvement" amount, the credit should automatically show on your bill. Anyone entitled to the credit that did not receive it must appeal directly to the Wisconsin Department of Revenue at 608-266-2486.

## Dog Licenses

Dog licenses are to be obtained every year, effective January 1st. Dog licenses can be obtained online by visiting <https://sunprairiewi.viewpointcloud.com/> or by downloading the form on our website and submitting it via mail, along with your dog's 'Certificate of Rabies' to 300 E Main Street. The dog's 'Certificate of Rabies' is required to be provided every year. Instructions for using the new online system will be available on our website.
