<b>Court of Appeals Judge District 4 Vote for 1</b>	Under state law, the increase in the levy of the City of Sun Prairie for the tax to be imposed for the next fiscal year, 2027, is limited to 5.462%, which results in a levy of \$39,792,820.  Shall the City of Sun Prairie be allowed to exceed this limit and increase the levy for the next fiscal year, 2027, for the purpose of maintaining current services, and increasing staffing in the police and fire departments, by a total of 9.926%, which results in a levy of \$43,742,820, and on an ongoing basis, include the increase of \$3,950,000 for each fiscal year going forward?
