RECEIPTS

For a receipt by mail, enclose a self-addressed, stamped business-sized envelope along with your tax bill and payment.

A receipt will **NOT** be provided unless a self-addressed, stamped envelope is included.

REFUNDS

If your escrow check exceeds the amount of your tax bill, you will be issued a refund check within 30 days of payment.

CHECK FOR CREDITS!

DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible! **To Qualify:** Your home must have been the **PRIMARY** residence for you or the previous owner on January 1, 2019. If you feel you qualify for the Lottery Credit: You may obtain the Lottery Credit Claim Form on our website, www.cityofsunprairie.com (Finance Department: Property Taxes Section), contact the Treasurer's Office at 300 East Main Street, or call 608-825-1192, **prior to January 31, 2020.**

AM I ELIGIBLE FOR THE FIRST DOLLAR CREDIT?

If your real estate bill has an "assessed value improvement" amount, the credit should automatically show on your bill. Anyone entitled to the credit that did not receive it must appeal directly to the Wisconsin Department of Revenue at 608-266-2486.

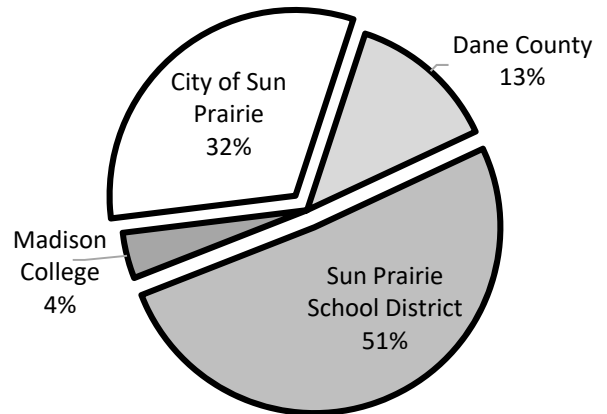
